PRODUCTIONS INCLUDE A MIX OF REINVIGORATED CLASSICS, CONTEMPORARY HITS, AND EXCEPTIONAL NEW WORKS. THE THEATRE'S ART REFLECTS ITS CORE VALUES OF ARTISTIC EXCELLENCE, DIVERSITY, INNOVATION, COLLABORATION, AND CELEBRATING THE HUMAN SPIRIT. THEATREWORKS PERFORMS IN THREE PENINSULA VENUES: MOUNTAIN VIEW CENTER FOR THE PERFORMING ARTS ("MVCPA"), LUCIE STERN THEATRE IN PALO ALTO, AND THE LOHMAN THEATRE IN LOS ALTOS.
